

The library of Ilia State University The rule for determining the replacement of library units lost by the reader and the actual literature

I Sphere of acting

- 1.1. These regulations govern the rules of the replacement of library units that are lost by the reader in the Library of Ilia State University and the definition of actual literature;
- 1.2. The rules for determining the substitution of library units and the actual literature lost by the reader is based on the Law of Georgia on Library Law, the rules and regulations for the use of Ilia State University Library.

II. Rule of replacement of lost library units

- 2.1. The library unit is regarded as which is received after signature (reader's form) is registered on the reader's name and is unable to return to its library due to various reasons.
- 2.2 The Individual Receipt Act (see Annex, Form # 1) on the books received and lost by the reader, and by the signature of the librarian and the reader.
- 2.3. The library's Cataloguing Division establishes and concludes the main members of the Library Commission (see the provisions of the Library, paragraph 10.4).
- 2.4 The Individual Receipt Act signed between the librarian and the reader is the foundation of the unified book received and lost by the readers.

III. The rule for determining the actual literature

- 3.1. Actual literature will be considered.
- 3.1.1 Frequently demanded library resource, which had been waiting for more than 3 and more than 3 readers within a month in the reservation queue.
- 3.1.2. Is unsuitable to use and damaged but requires and there is a new edition;



3.1.3. The literature of the newly translated artistic and scientific content that lacks the library and serves the reader's educational, research and cultural development.

3.2. The list of actual literature is based on the data of all the libraries of the Ilia State University library (see Annex: Form # 3).

3.3 The principal members of the Library Commission are approved by the List of Actual Literature (see the provisions of the Library, paragraph 10.4).

3.4. The list is renewed once in 6 months by the head of the service department.
